7 **A Resolution authorizing the Executive to advertise for bids for the disposal of sludge from**
8 **both the Fishcreek Wastewater Treatment Plant #25, located in the City of Stow, and the**
9 **Upper Tuscarawas Wastewater Treatment Plant #36, located in Springfield Township, in**
10 **Council Districts 3 and 8, to a solid waste landfill, for a three year term, for an estimated**
11 **total cost not to exceed \$1,025,000.00, for the Executive's Department of Sanitary Sewer**
12 **Services, and declaring an emergency.**

14 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
15 requires this Council's authorization for the Executive to advertise for bids; and

16
17 WHEREAS, sludge, generated from wastewater treatment plants ("WWTP"), is required
18 to be disposed of in accordance with the Ohio Environmental Protection Agency regulations and
19 the disposal at a solid waste landfill meets those regulations; and

20
21 WHEREAS, the Executive wishes to advertise for bids for the disposal of sludge from
22 both the Fishcreek WWTP #25, located in the City of Stow, and the Upper Tuscarawas WWTP
23 #36, located in Springfield Township, in Council Districts 3 and 8, to a solid waste landfill, for a
24 three year term, for an estimated total cost not to exceed \$1,025,000.00; and

26 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;
27 and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
31 advertise for bids for the aforementioned disposal of sludge;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

36 SECTION 1

38 The Executive is hereby authorized to advertise for bids for the disposal of sludge from
39 both the Fishcreek Wastewater Treatment Plant ("WWTP") #25, located in the City of Stow, and
40 the Upper Tuscarawas WWTP #36, located in Springfield Township, in Council Districts 3 and
41 8, to a solid waste landfill, for a three year term, for an estimated total cost not to exceed
42 \$1,025,000.00.

46 This Resolution is declared an emergency in the interest of the health, safety and welfare
47 of the residents of the County of Summit, and for the further reason that it authorizes the
48 Executive to immediately advertise for the disposal of sludge from the Fishcreek WWTP #25
49 and the Upper Tuscarawas WWTP #36 to maintain compliance with Ohio Environmental
50 Protection Agency requirements.
