A Resolution authorizing the Executive to execute an amendment to the existing Sanitary Sewer Service Agreement between the County and the Northeast Ohio Regional Sewer District, dated October 22, 1987, to amend the City of Hudson's sanitary sewer service area, located in the City of Hudson, in Council District 3, for the Executive's Department of Sanitary Sewer Services, and declaring and emergency.

WHEREAS, this Council previously adopted Resolution No. 86-647, which authorized the Executive to execute an Agreement with the Northeast Ohio Regional Sewer District ("District"), dated October 22, 1987 ("Agreement #1677"), whereby the County abandoned the Macedonia Wastewater Treatment Plant No. 15 and constructed sewer improvements that diverted and discharged wastewater flow to the Cuyahoga Valley Interceptor; and

WHEREAS, this Council subsequently adopted Resolution No. 2000-182, which authorized the Executive to execute a Contract Modification Agreement with the District, dated May 18, 2000, that modified Agreement #1677 to expand the service area to include the City of Hudson; the County and District previously supplemented Agreement #1677 to identify that "1677-A" includes additional areas and modifications in the service area; and

WHEREAS, this Council subsequently adopted Resolution No. 2011-484, which authorized the Executive to execute an Amendment to Agreement #1677 with the District, dated January 19, 2012, that modified the billing arrangements to migrate from a master meter billing to a billing model based on water consumption by the County's customers; and

WHEREAS, the County has determined that it is necessary to amend the service area as described in Agreement #1677, to include certain portions of the City of Hudson that do not currently receive wastewater services from the County and the District and to remove the areas in Hudson that are not being served by the County and the District, as described in the Amendment to Service Agreement No. 1677, by and between the Northeast Ohio Regional Sewer District and the County of Summit, Ohio Providing for the Inclusion of the City of Hudson into the Northeast Ohio Regional Sewer District ("Amendment"); and

WHEREAS, the City of Hudson, by Resolution No. 25-86, passed on June 3, 2025, approves amending the service area to include the portions of the City of Hudson receiving services provided by the County and the District, and removing the areas not being served, as set forth in the Amendment; and

WHEREAS, the County desires to enter into the Amendment, which is attached and incorporated herein by reference as Exhibit A, to amend Agreement #1677 to accurately include the portions of the City of Hudson being served by the District and County; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned Amendment with the District and any other necessary and related documents;
