A Resolution confirming the award of the Board of Control of a construction contract with Quorum Group, LLC dba Takeform, under Other Public Cooperative Purchasing Association Pricing, for the Summit County Parking Deck Signage Project, located in the City of Akron, in Council District 4, in an amount not to exceed \$98,578.61, for the Executive's Department of Administrative Services-Physical Plants, and declaring an emergency.

WHEREAS, the original Parking Deck was built in 1977, and 2 upper decks were added in 2002. The first major renovation since then has been undertaken to allow the County to help provide a safer, cleaner parking deck well into the future; and

WHEREAS, the current signage in the Parking Deck is old and not coordinated as various signs were added over time and some signs have become worn and/or damaged; and

WHEREAS, the Executive's Department of Administrative Services-Physical Plants wishes to undertake the Summit County Parking Deck Signage Project (the "Project") to upgrade the signage in the Parking Deck to make sure it is unified, easily visible, and ADA compliant; and

WHEREAS, pursuant to Section 177.07 (a)(11) of the Codified Ordinances of the County of Summit, Quorum Group, LLC dba Takeform ("Takeform") is an approved Other Public Cooperative Purchasing Association Pricing vendor and as such is exempt from competitive bidding; and

WHEREAS, the Executive wishes to enter into a construction contract with Takeform, for the Project, in an amount not to exceed \$98,578.61; and

WHEREAS, the Board of Control at its meeting held on August 6, 2025, awarded a construction contract with Quorum Group, LLC dba Takeform ("Takeform"), under Other Public Cooperative Purchasing Association Pricing, for the Summit County Parking Deck Signage Project, located in the City of Akron, in Council District 4, in an amount not to exceed \$98,578.61, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with Takeform is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The award by the Board of Control of a construction contract with Quorum Group, LLC dba Takeform, under Other Public Cooperative Purchasing Association Pricing, for the Summit County Parking Deck Signage Project, located in the City of Akron, in Council District 4, in an amount not to exceed \$98,578.61, is hereby confirmed and the Executive is hereby authorized to execute said contract and any other necessary related documents.

SECTION 2
