A Resolution confirming the award by the Board of Control of a professional service contract with Oriana House, Inc., as a Best Practical Source, for community corrections services, for the period 7/1/25 through 6/30/27, in an amount not to exceed \$2,691,940.00, for the Executive's Department of Public Safety, and declaring an emergency.

WHEREAS, under the CCA 2.0 grant program, the Ohio Department of Rehabilitation and Correction ("ODRC") awarded a grant in the amount of \$7,779,824.00 to the County of Summit, for the period 7/1/25 through 6/30/27, with no local cash match requirement, to support maintaining offenders locally and being able to provide alternative community corrections housing and programming; and

WHEREAS, this grant funding is provided to the Court of Common Pleas for the Intensive Supervised Probation program and court assessments; the Sheriff's Office for costs associated with the management and housing individuals locally in lieu of prison; and Oriana House, Inc., which currently provides community corrections services; and

WHEREAS, Oriana House, Inc. is a Best Practical Source pursuant to Sections 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit as they currently provide similar community corrections services under the Community Corrections Act grant 407 and 408 contracts previously adopted by this Council (Resolution Nos. 2021-219, 2021-220 and 2022-120, 2023-196 respectively), as well as the general fund, which was subject to the Request for Proposal process; and

WHEREAS, the Board of Control, at its meeting held August 13, 2025, awarded a professional service contract with Oriana House, Inc., as a Best Practical Source, for community corrections services, for the period 7/1/25 through 6/30/27, in an amount not to exceed \$2,691,940.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned professional service contract with Oriana House, Inc. is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## **SECTION 1**

 The award by the Board of Control of a professional service contract with Oriana House, Inc., as a Best Practical Source, for community corrections services, for the period 7/1/25 through 6/30/27, in an amount not to exceed \$2,691,940.00, is hereby confirmed and the Executive is hereby authorized to execute said professional service contract and any other necessary related documents.
