7 **A Resolution confirming the award by the Board of Control of a purchase contract with**  
8 **ComDoc A Xerox Company, under Equalis Group Public Cooperative Purchasing**  
9 **Association pricing, for a Versant 280 Press copier, in an amount not to exceed**  
10 **\$131,943.00, utilizing the Internal Lease Fund, for the Executive's Department of Finance**  
11 **and Budget – Office Services, and declaring an emergency.**

13 WHEREAS, the Executive's Department of Finance and Budget – Office Services wishes  
14 to upgrade its existing fleet of copiers and wishes to enter into a purchase agreement for a new  
15 Versant 280 Press copier, including attachments and installation; and

16  
17 WHEREAS, the aforementioned copier provides copies at a less expensive rate than the  
18 copier it will replace; and

19  
20 WHEREAS, the purchase cost is offered under Equalis Group Public Cooperative  
21 Purchasing Association pricing making this purchase exempt from County competitive  
22 procurement pursuant to Section 177.07(a)(11) of the Codified Ordinance of the County of  
23 Summit; and

25 WHEREAS, this purchase will use the County's Internal Lease Fund with the Fund  
26 making the purchase payment and the Executive's Department of Finance and Budget – Office  
27 Services making lease payments to the Fund; and

29 WHEREAS, the Board of Control, at its meeting held on August 13, 2025, subject to the  
30 approval of the Information Technology Board, awarded a purchase contract with ComDoc A  
31 Xerox Company, under Equalis Group Public Cooperative Purchasing Association pricing, for a  
32 Versant 280 Press copier, in an amount not to exceed \$131,943.00, utilizing the Internal Lease  
33 Fund, subject to confirmation by this Council; and

35 WHEREAS, the Information Technology Board, at its meeting held on August 21, 2025,  
36 approved the aforementioned purchase contract with ComDoc A Xerox Company; and

38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
39 that the aforementioned purchase contract with ComDoc A Xerox Company is necessary and in  
40 the best interest of the County of Summit;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
43 of Ohio, that:

47 The award by the Board of Control, as approved by the Information Technology Board,  
48 of a purchase contract with ComDoc A Xerox Company, under Equalis Group Public  
49 Cooperative Purchasing Association pricing, for a Versant 280 Press copier, in an amount not to  
50 exceed \$131,943.00, utilizing the Internal Lease Fund, is hereby confirmed and the Executive is  
51 hereby authorized to execute said purchase contract and any other necessary related documents.
