7 **A Resolution confirming the award by the Board of Control of a construction contract with**  
8 **Kenmore Construction Co. Inc. for Project Q-183 Pump Station No. 6 Replacement,**  
9 **located in the Cities of Hudson and Stow, in Council District 3, in an amount not to exceed**  
10 **\$6,761,800.00, for the Executive's Department of Sanitary Sewer Services, and declaring an**  
11 **emergency.**

12  
13 WHEREAS, this Council previously adopted Resolution No. 2024-310 which authorized  
14 the Executive to advertise for bids for Project Q-183 Pump Station No. 6 Replacement ("Project  
15 Q-183") located in the Cities of Hudson and Stow, in Council District 3, for an estimated total  
16 cost not to exceed \$5,921,457.00; and

17  
18 WHEREAS, it is necessary to construct a replacement for Pump Station No. 6 and  
19 upgrade Pump Station No. 13 with Project Q-183; and

20  
21 WHEREAS, after receiving one bid for Project Q-183, the Executive selected Kenmore  
22 Construction Co. Inc. as the lowest responsive and responsible bidder with a bid of  
23 \$6,761,800.00; and

24  
25 WHEREAS, the Board of Control, at its meeting held September 3, 2025, awarded a  
26 construction contract with Kenmore Construction Co. Inc., as the lowest responsive and  
27 responsible bidder, for Project Q-183, in an amount not to exceed \$6,761,800.00, subject to  
28 confirmation by this Council; the bid amount is \$840,343.00 and 14.19% over the \$5,921,457.00  
29 estimate certified for the project which exceeds 10% and requires approval by this Council under  
30 Section 177.02(c) of the Codified Ordinances of the County of Summit; and

32 WHEREAS, this Council finds and determines after reviewing all pertinent information  
33 that the aforementioned construction contract with Kenmore Construction Co. Inc. is necessary  
34 and in the best interest of the County;

36 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that:

41 The award by the Board of Control of a construction contract with Kenmore Construction  
42 Co. Inc., for Project Q-183 Pump Station No. 6 Replacement, located in the Cities of Hudson and  
43 Stow, in Council District 3, in an amount not to exceed \$6,761,800.00, is hereby confirmed and  
44 the Executive is hereby authorized to execute said construction contract and any other necessary  
45 related documents.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and  
50 welfare of the residents of the County of Summit, and for the further reason to immediately  
51 authorize the Executive to provide for necessary construction work for the project.
