7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **the Metro Regional Transit Authority, to provide Non-Emergency Medical Transportation**
9 **Broker services for a one-year term, from 10/1/25 through 9/30/26, in an amount not to**
10 **exceed \$500,000.00, for the Executive’s Department of Job and Family Services, and**
11 **declaring an emergency.**

12

13 WHEREAS, the Executive’s Department of Job and Family Services’ (“DJFS”) wishes to
14 enter into a purchase contract with the Metro Regional Transit Authority to provide Non-
15 Emergency Medical Transportation (“NET”) Transport Broker services. NET provides state
16 mandated transportation services for Medicaid eligible Summit County residents to medical
17 appointments, both in and out of the county; and

18

19 WHEREAS, the Metro Regional Transit Authority will provide call center services to
20 accept calls from DJFS NET customers and schedule transportation with DJFS contracted
21 transportation providers, according to customer mobility assistance requirements; and

22

23 WHEREAS, NET Transport Broker services will also ensure transportation providers
24 maintain all required service documentation, licensures, driver qualifications, driver trainings,
25 insurance coverage and vehicle standards in accordance with state regulations; and

27 WHEREAS, said contract will be paid utilizing State and Federal Medicaid pass-through
28 funding which is considered 100% reimbursable; and

30 WHEREAS, the Board of Control, at its meeting held September 3, 2025, awarded a
31 purchase contract with the Metro Regional Transit Authority, to provide Non-Emergency
32 Medical Transportation Broker services for a one-year term, from 10/1/25 through 9/30/26, in an
33 amount not to exceed \$500,000.00, subject to confirmation by this Council; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information
36 that the aforementioned purchase contract with the Metro Regional Transit Authority is
37 necessary and in the best interest of the County of Summit;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that:

44 The award by the Board of Control of a purchase contract with the Metro Regional
45 Transit Authority for Non-Emergency Medical Transportation (“NET”) Broker services for a
46 one-year term, from 10/1/25 through 9/30/26, in an amount not to exceed \$500,000.00, is hereby
47 confirmed and the Executive is hereby authorized to execute said purchase contract and any
48 other necessary related documents.
