A Resolution declaring the imminent failure of the force main, near Valleyview Road under State Route 8, located in the City of Macedonia, in Council District 1, an emergency pursuant to Section 177.07(a)(3) of the Codified Ordinances of the County of Summit, and confirming the award by the Board of Control of a construction contract with Wingfoot Rental & Development Co., in an amount not to exceed \$537,884.79, for an emergency repair to the force main, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, due to numerous emergency repairs of the force main on Valleyview Road, the potential of an imminent failure existed of the same force main located under State Route 8; therefore, emergency repairs were required to replace the existing 18 inch ductile iron force main with a 20 inch high-density polyethylene pipe (HDPE) that was directionally drilled underneath State Route 8, and the existing discharge vault was replaced, located in the City of Macedonia, in Council District 1; and

WHEREAS, Wingfoot Rental & Development Co. was directed to make the emergency repairs based on their expertise, availability and performance on similar projects; and

WHEREAS, the above referenced circumstances made it necessary for the County to utilize Wingfoot Rental & Development Co. for an emergency repair of the force main to be returned to normal operations as quickly as possible; and

WHEREAS, the Board of Control, at its September 3, 2025 meeting, awarded a construction contract with Wingfoot Rental & Development Co. for an emergency repair of said force main, in an amount not to exceed \$537,884.79, subject to the confirmation of this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned repairs constitute an emergency repair under Section 177.07(a)(3) of the Codified Ordinances of the County of Summit and further finds and determines that it is necessary and in the best interest of the County of Summit to confirm the award by the Board of Control of a construction contract with Wingfoot Rental & Development Co. for said emergency repair of the force main, in an amount not to exceed \$537,884.79;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

This Council finds and determines that the repair of the force main, located near Valleyview Road under State Route 8, located in the City of Macedonia, in Council District 1, is an emergency pursuant to Section 177.07(a)(3) of the Codified Ordinance of the County of Summit.

The award by the Board of Control of a construction contract with Wingfoot Rental & Development Co. for an emergency repair of the force main, located near Valleyview Road under State Route 8, located in the City of Macedonia, in Council District 1, in an amount not to exceed \$537,884.79, is hereby confirmed and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.

SECTION 3

This Resolution is declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason to immediately authorize a necessary construction contract with Wingfoot Rental & Development Co. for an emergency repair of the force main located in the City of Macedonia, in Council District 1.

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 5

It is found and determined that all formal actions of the Council concerning and relating to the adoption of the Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
