A Resolution confirming the award by the Board of Control of a professional service contract with Oriana House, Inc., as a Best Practical Source, for two full-time case managers, to provide support and treatment services to Valor Court participants, for a one-year term, from 9/30/25 through 9/29/26, in an amount not to exceed \$133,473.00, for the Court of Common Pleas-General Division, Adult Probation, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution Nos. 2020-091, 2021-015, 2021-277, 2022-339, 2023-378, which approved professional service contracts with Oriana House, Inc., for two full-time case managers and one full-time recovery support specialist, to provide support and treatment services to Valor Court participants, for one-year terms; and

WHEREAS, this Council subsequently adopted Resolution No. 2025-016, which approved a professional service contract with Oriana House, Inc., for two full-time case managers, to provide support and treatment services to Valor Court participants, for a one-year term; and

WHEREAS, this contract will be funded through a United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration ("SAMSHA") for the Valor Court Expansion and Enhancement Project; and

WHEREAS, based on performance reviews and Oriana House Inc.'s specialized knowledge and previous years working with the Valor Court, the Court of Common Pleas-General Division, Adult Probation, wishes to enter into a professional service contract with Oriana House, Inc., which is a Best Practical Source pursuant to Sections 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit; and

WHEREAS, the Board of Control, at its meeting held on September 10, 2025, awarded the aforementioned contract with Oriana House, Inc., as a Best Practical Source, for case management services for Valor Court participants, for a one-year term, from 9/30/25 through 9/29/26, in an amount not to exceed \$133,473.00, subject to confirmation by this Council, and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with Oriana House, Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The award by the Board of Control of a professional service contract with Oriana House, Inc., as a Best Practical Source, for case management services to Valor Court participants, for a one-year term, from 9/30/25 through 9/29/26, in an amount not to exceed \$133,473.00, is hereby confirmed and the Executive is hereby authorized to execute said professional service contract and any other necessary related documents.
