A Resolution confirming the award by the Board of Control of a renewal of a professional service contract with Interval Brotherhood Homes, Inc., dba IBH Addiction Recovery, for peer support services for Valor Court participants, for a one-year term, from 9/30/25 through 9/29/26, in an amount not to exceed \$87,471.00, for the Court of Common Pleas-General Division, Adult Probation, and declaring an emergency.

WHEREAS, on December 16, 2024, the Court of Common Pleas-General Division (the "Court"), through the County of Summit, advertised Requests for Proposals to provide peer support services to Valor Court participants; and

WHEREAS, by the deadline of January 30, 2025, with Interval Brotherhood Homes, Inc., dba IBH Addiction Recovery ("IBH Addiction Recovery") submitted the highest scoring proposal, and the Court selected IBH Addiction Recovery to provide peer support service for Valor Court participants; and

WHEREAS, the Board of Control, at its meeting held March 12, 2025, approved the aforementioned professional service contract with IBH Addiction Recovery, for a six month term, for the period of 4/1/25 to 9/30/25, with one option to renew for an additional one-year term, in an amount not to exceed \$40,061.00; and

WHEREAS, this contract is funded through a United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration ("SAMSHA") for the Valor Court Expansion and Enhancement Project; and

WHEREAS, the Court wishes to renew this agreement for a one-year term to continue to provide peer support service for Valor Court participants; and

WHEREAS, the Board of Control, at its meeting held September 10, 2025, awarded the aforementioned renewal of a professional service contract with IBH Addiction Recovery, for peer support services for Valor Court participants, for a one-year term, from 9/30/25 through 9/29/26, in an amount not to exceed \$87,471.00, and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the renewal of the professional service contract with IBH Addiction Recovery is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The award by the Board of Control of a professional service contract with Interval Brotherhood Homes, Inc., dba IBH Addiction Recovery, for peer support services to Valor Court participants, for a one-year term, from 9/30/25 through 9/29/26, in an amount not to exceed \$87,741.00, is hereby confirmed and the Executive is hereby authorized to execute said renewal of a professional service contract and any other necessary related documents.
