An Amended Resolution authorizing the Executive to execute grant agreements with the Development Finance Authority of Summit County, the City of Akron, Akron Public Schools, Summit Metro Parks, the Akron-Summit County Public Library, the Akron Zoological Park, the Summit County Board of Developmental Disabilities Board, the Summit County Children Services Board and the Summit County Alcohol Drug and Mental Health Services Board, for the distribution of proceeds from the sale of the real property located at 1 Cascade Plaza, Akron, Ohio 44308, in Council District 4, for the Executive, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2023-245, which authorized the Executive to enter into a Term Sheet and Cooperative Agreement ("Agreements") with the Development Finance Authority of Summit County ("DFA") and the Summit County Land Reutilization Corporation providing for the terms of the acquisition, management and eventual disposition of the real property located at 1 Cascade Plaza, Akron, Ohio 44308 (the "Property"),

in Council District 4; and

WHEREAS, under the terms of said Agreements, proceeds from the sale of the Property, if sufficient, would be used to repay, on a pro-rata basis, all political subdivisions that would have received any delinquent or current real estate taxes assessed against the Property that were otherwise discharged and foregone as a result of the transfer of the Property via conveyance in lieu of foreclosure or that were exempted during the period of ownership of the Property by the Land Bank; and

WHEREAS, the sale of said property to PVC Cascade One LLC on February 28, 2025 for \$2,800,000.00 provided sufficient funds to satisfy all of the otherwise discharged and foregone delinquent or current real estate taxes assessed against the Property; and

WHEREAS, in order to satisfy the terms of said Agreements, it is necessary for the Executive to enter into a grant agreement with the DFA, enabling the DFA to send sales proceeds totaling \$929,355.79, to be disbursed to the taxing authorities who levy taxes against the Property; and

WHEREAS, in order to satisfy the terms of said Agreements, it is necessary for the Executive to enter into grant agreements with the taxing authorities who levy taxes against the Property in order to distribute the \$929,355.79 from the sales proceeds of the Property to provide the funds contemplated in the Agreements as follows:

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit, to authorize the Executive to execute grant agreements with the Development Finance Authority of Summit County, the City of Akron, Akron Public Schools, Summit Metro Parks, the Akron-Summit County Public Library, the Akron Zoological Park, the Summit County Board of Developmental Disabilities, the Summit County Children Services Board and the Summit County Alcohol Drug and Mental Health Services Board, for the distribution of proceeds from the sale of the real property located at 1 Cascade Plaza, Akron, Ohio 44308, in Council District 4; and

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The Executive is hereby authorized to execute a grant agreement with the Development Finance Authority of Summit County, enabling the DFA to send sales proceeds totaling \$929,355.79, from the sale of real property located at 1 Cascade Plaza, Akron, Ohio 44308, in Council District 4, to be disbursed to the taxing authorities who levy taxes against the Property.

SECTION 2

The Executive is hereby authorized to execute grant agreements with the City of Akron, Akron Public Schools, Summit Metro Parks, the Akron-Summit County Public Library, the Akron Zoological Park, the Summit County Board of Developmental Disabilities, the Summit County Children Services Board and the Summit County Alcohol Drug and Mental Health Services Board, for the distribution of proceeds from the sale of the real property located at 1 Cascade Plaza, Akron, Ohio 44308, in Council District 4 totaling \$929,355.79.

SECTION 3

 This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately proceeds from the sale of the Property to repay all political subdivisions that would have received any delinquent or current real estate taxes assessed against the Property that were otherwise discharged and foregone as a result of the transfer of the Property via conveyance in lieu of foreclosure or that were exempted during the period of ownership of the Property by the Land Bank

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
