7 **A Resolution authorizing the Executive to advertise for bids for the Ohio Building Elevator**
8 **Project, located in the City of Akron, in Council District 4, for an estimated total cost not to**
9 **exceed \$840,000.00, for the Executive’s Department of Administrative Services–Physical**
10 **Plants, and declaring an emergency.**

12 WHEREAS, the Executive’s Department of Administrative Services–Physical Plants has
13 determined there is a need for the replacement of the two main elevators in the Ohio Building;
14 and

16 WHEREAS, the Ohio Building Elevator Project (the “Project”) will accomplish this goal;
17 and

19 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
20 requires this Council’s authorization for the Executive to advertise for bids; and

22 WHEREAS, the Executive wishes to advertise for bids for the aforementioned Project,
23 for an estimated total cost not to exceed \$840,000.00; and

25 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council’s Office;

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that is necessary and in the best interest of the County of Summit to authorize the Executive to
30 advertise for bids for the Project, for an estimated total cost not to exceed \$840,000.00;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The Executive is hereby authorized to advertise for bids for the Ohio Building Elevator
38 Project, located in the City of Akron, in Council District 4, for an estimated total cost not to
39 exceed \$840,000.00.

43 This Resolution is declared an emergency in the interest of the health, safety, and welfare
44 of the residents of the County of Summit, and for the further reason that it authorizes the
45 Executive to immediately advertisement for bids for necessary improvements for the Ohio
46 Building.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
52 effect and be in force at the earliest time provided by law.
