WHEREAS, the Ohio Legislature passed House Bill 2 in 2024, which included \$50 million in funding to the Ohio Department of Rehabilitation and Correction to award grants for

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned H.B. 2 Local Jail Capital Project Grant from the ODRC;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
