A Resolution confirming the award by the Board of Control of a professional service contract with Apex Benefits Services, LLC dba Apex Health Solutions, to provide medical administration for SummaCare, Ohio Health and First Health Networks, for a three-year term, from 1/1/26 through 12/31/28, in an amount not to exceed \$675,000.00, for the Executive's Department of Human Resources – Division of Employee Benefits, and declaring an emergency.

WHEREAS, after a review of the County's health insurance programs, the Executive wishes to execute a professional service contract with Apex Benefits Services, LLC dba Apex Health Solutions ("Apex"), to provide medical administration for SummaCare Network, Ohio Health Choice and First Health Wrap, for a three-year term, from 1/1/26 through 12/31/28, in an amount not to exceed \$675,000.00; and

WHEREAS, all costs and fees for the administrative services per employee per month (PEPM) are set forth on Exhibit B, attached to this Resolution and incorporated herein as if fully restated; and

WHEREAS, the Board of Control, at its September 24, 2025 meeting, awarded a professional service contract with Apex, to provide medical administration for SummaCare Network, Ohio Health Choice and First Health Wrap, for a three-year term, from 1/1/26 through 12/31/28, in an amount not to exceed \$675,000.00, subject to confirmation by this Council;

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with Apex is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

 The award by the Board of Control of a professional service contract with Apex Benefits Services, LLC dba Apex Health Solutions ("Apex"), to provide medical administration for SummaCare Network, Ohio Health Choice and First Health Wrap, for a three-year term, from 1/1/26 through 12/31/28, in an amount not to exceed \$675,000.00, is hereby confirmed and the Executive is hereby authorized to execute said professional service contract and any other necessary related documents.
