8 **A Resolution confirming the award by the Board of Control of a professional service**
9 **contract with Apex Benefits Services, LLC dba Apex Health Solutions, to provide medical**
10 **administration for SummaCare, Ohio Health and First Health Networks, for a three-year**
11 **term, from 1/1/26 through 12/31/28, in an amount not to exceed \$675,000.00, for the**
12 **Executive's Department of Human Resources – Division of Employee Benefits, and**
13 **declaring an emergency.**

15 WHEREAS, after a review of the County's health insurance programs, the Executive
16 wishes to execute a professional service contract with Apex Benefits Services, LLC dba Apex
17 Health Solutions ("Apex"), to provide medical administration for SummaCare Network, Ohio
18 Health Choice and First Health Wrap, for a three-year term, from 1/1/26 through 12/31/28, in an
19 amount not to exceed \$675,000.00; and

21 WHEREAS, all costs and fees for the administrative services per employee per month
22 (PEPM) are set forth on Exhibit B, attached to this Resolution and incorporated herein as if fully
23 restated; and

25 WHEREAS, the Board of Control, at its September 24, 2025 meeting, awarded a
26 professional service contract with Apex, to provide medical administration for SummaCare
27 Network, Ohio Health Choice and First Health Wrap, for a three-year term, from 1/1/26 through
28 12/31/28, in an amount not to exceed \$675,000.00, subject to confirmation by this Council;

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that the aforementioned professional service contract with Apex is necessary and in the best
32 interest of the County of Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

39 The award by the Board of Control of a professional service contract with Apex Benefits
40 Services, LLC dba Apex Health Solutions ("Apex"), to provide medical administration for
41 SummaCare Network, Ohio Health Choice and First Health Wrap, for a three-year term, from
42 1/1/26 through 12/31/28, in an amount not to exceed \$675,000.00, is hereby confirmed and the
43 Executive is hereby authorized to execute said professional service contract and any other
44 necessary related documents.

50 Apex to continue to provide medical administration services to County employees and
