A Resolution confirming the award by the Board of Control of Change Order No. 1 to a professional service contract with Apex Benefit Services LLC dba Apex Health Solutions, to provide administrative services for the County's SummaCare health insurance coverage and claims, for a one-year term, from 1/1/25 through 12/31/25, in an amount not to exceed \$92,000.00, (for a cumulative increase of 75.41%) for a total amount not to exceed \$214,000.00, for the Executive's Department of Human Resources – Division of Employee Benefits, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2024-332, which authorized the Executive to execute contracts for the County's health insurance program including a professional service contract with Apex Benefit Services LLC dba Apex Health Solutions ("Apex"), to provide administrative services for the County's SummaCare health insurance coverage and claims, for a one-year term, from 1/1/25 through 12/31/25, in an amount not to exceed \$122,000.00; and

WHEREAS, the aforementioned contract did not include the costs of administration of the County's pharmacy coverage and claims with SummaCare necessitating this proposed change order to said contract; and

WHEREAS, the Board of Control, at its September 24, 2025 meeting, awarded Change Order No. 1 to a professional service contract with Apex, to provide administrative services for the County's SummaCare health insurance coverage and claims, for a one-year term, from 1/1/25 through 12/31/25, in an amount not to exceed \$92,000.00, (for a cumulative increase of 75.41%) for a total amount not to exceed \$214,000.00, subject to confirmation by this Council;

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned Change Order No. 1 to a professional service contract with Apex is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

 The award by the Board of Control of Change Order No. 1 to a professional service contract with Apex Benefit Services LLC dba Apex Health Solutions ("Apex"), to provide administrative services for the County's SummaCare health insurance coverage and claims, for a one-year term, from 1/1/25 through 12/31/25, in an amount not to exceed \$92,000.00, (for a cumulative increase of 75.41%) for a total amount not to exceed \$214,000.00, is hereby confirmed and the Executive is hereby authorized to execute said change order any other necessary related documents.
