7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with The Amazing Cloud, LLC., as a Best Practical Source, for Disaster Recovery**
9 **as a Service, for a nineteen-month term, from 1/1/26 through 7/31/27, for a total amount**
10 **not to exceed \$130,625.00, for the Office of Information Technology, and declaring an**
11 **emergency.**

13 WHEREAS, Disaster Recovery as a Service (“DRaaS”) is the replication and hosting of
14 physical or virtual servers by a third party to provide failover in the event of a natural
15 catastrophe, power outage, or another type of business disruption; and

16
17 WHEREAS, the County requires the management of the County’s DRaaS hardware in
18 the Fairlawn Gig datacenter; and

19
20 WHEREAS, The Amazing Cloud, LLC is a Best Practical Source pursuant to Sections
21 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit because
22 they are the only company capable of servicing the equipment at the Fairlawn Gig data center
23 and they are the only company that can utilize the connection from the Ohio Building to the
24 Fairlawn Gig data center; and

26 WHEREAS, the County has been utilizing The Amazing Cloud, LLC for DRaaS for the
27 past five years and the Office of Information Technology recommends that the County enter into
28 a professional service contract with The Amazing Cloud, LLC for DRaaS, for a nineteen-month
29 term, from 1/1/26 through 7/31/27, for \$6,875.00 per month, for a total not to exceed amount of
30 \$130,625.00 for term of the agreement; and

32 WHEREAS, the Board of Control, at its meeting held October 1, 2025, awarded the
33 aforementioned professional service contract, subject to the approval of the Information
34 Technology Board, with The Amazing Cloud, LLC for DRaaS, as a Best Practical Source,
35 subject to confirmation by this Council; and

37 WHEREAS, the Information Technology Board, at its meeting held October 9, 2025,
38 approved the aforementioned professional service contract with The Amazing Cloud, LLC for
39 DRaaS; and

41 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
42 that the aforementioned professional service contract with The Amazing Cloud, LLC, is
43 necessary and in the best interest of the County of Summit;

6 The award by the Board of Control of a professional service contract with The Amazing
7 Cloud, LLC, approved by the Information Technology Board on October 9, 2025, for Disaster
8 Recovery as a Service (“DRaaS”), for a nineteen-month term, from 1/1/26 through 7/31/27, for
9 \$6,875.00 per month, for a total not to exceed amount of \$130,625.00, is hereby confirmed and
10 the Executive is hereby authorized to execute said professional service contract and any other
11 necessary related documents.

14 This Resolution is hereby declared an emergency in the interest of the health, safety, and
15 welfare of the residents of the County of Summit and for the further reason of immediately
16 authorizing a necessary professional service contract for DRaaS.

20 Provided this Resolution receives the affirmative vote of eight members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.
