A Resolution confirming the award by the Board of Control of Change Order No. 1 to a purchase contract with Avertest, LLC dba Averhealth for on-site drug screen testing services, for a one-year term, from 12/15/24 through 12/14/25, in an amount not to exceed \$64,746.00, (for a cumulative increase of 30.00%), for a total amount not to exceed \$280,566.00, for the Court of Common Pleas-General Division, Adult Probation Department, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2024-314, which authorized the Executive to execute a purchase contract for drug testing services with Avertest, LLC dba Averhealth ("Averhealth"), for the Court of Common Pleas-General Division, Adult Probation Department (the "Court"), for a one-year term, from 12/14/24 through 12/15/25, in an amount not to exceed \$215,820.00; and

WHEREAS, the Court has utilized Averhealth drug testing services for criminal defendants more than previously anticipated therefore the Court anticipates exceeding the original not to exceed amount; and

WHEREAS, the Board of Control, at its meeting held on October 29, 2025, awarded Change Order No. 1 to a purchase contract with Averhealth, to provide increased drug testing services to criminal defendants, for a one-year term, from 12/15/24 through 12/14/25, in an amount not to exceed \$64,746.00, (for a cumulative increase of 30.00%), for a total amount not to exceed \$280,566.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned change order to a purchase contract with Avertest, LLC dba Averhealth is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of Change Order No. 1 to a purchase contract with Avertest, LLC dba Averhealth for on-site drug screen testing services, for a one-year term, from 12/15/24 through 12/14/25, in an amount not to exceed \$64,746.00, (for a cumulative increase of 30.00%), for a total amount not to exceed \$280,566.00, is hereby confirmed and the Executive is hereby authorized to execute said change order and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately provide necessary increased drug screen testing services for the Court of Common Pleas-General Division, Adult Probation Department.
