A Resolution authorizing the Executive and Sheriff to apply for and the Executive to execute any documents necessary to accept the award from the Ohio Department of Public Safety's Office of Criminal Justice Services, a Drug Law Enforcement Fund grant, up to an amount of \$250,000.00, with a 25% local cash match requirement up to an amount of \$83,333.33, for a project total up to an amount \$333,333.33, for the period 7/1/26 through 6/30/27, for the Sheriff, and declaring an emergency.

WHEREAS, a Drug Law Enforcement Fund ("DLEF") grant proposal from the State of Ohio, Department of Public Safety/Office of Criminal Justice Services will open in December 2025 for the grant period 7/1/2026 through 6/30/2027 for which the County will submit an application; and

WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services, ("ODPS-OCJS") has historically awarded the Sheriff's Office a Drug Law Enforcement Fund ("DLEF") grant, with a 25% local cash match requirement provided by funds from the Sheriff's Summit County Drug Unit checking account; and

WHEREAS, the DLEF grant for the period 7/1/26 through 6/30/27 will fund the salary of one Sheriff's Office Drug Unit detective, office space and vehicle fuel and maintenance to address the problem of illegal drugs in Summit County; and

WHEREAS, the maximum ODPS-OCJS DLRF award amount of this grant is \$250,000.00, with a 25% cash match required, for a potential maximum cash match of \$83,333.33; and

WHEREAS, the formal award letter with final financial information will not be provided until the Pre-award Conditions package is submitted to ODPS-OCJS and approved. Previous year's grant awards were approximately 55% of the maximum award amount. Both FY2023 and FY2024 grant awards were \$136,875.00 with cash matches of \$45,625.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to apply for and accept the award of the aforementioned DLEF grant from the ODPS-OCJS;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The Executive and Sheriff are here authorized to apply for, and the Executive is hereby authorized to execute any documents necessary to accept the award from the Ohio Department of Public Safety's Office of Criminal Justice Services ("ODPS-OCJS"), of a Drug Law Enforcement Fund ("DLEF") grant, up to an amount of \$250,000.00, with a 25% local cash match requirement up to an amount of \$83,333.33, for a project total up to an amount \$333,333.33, for the period 7/1/26 through 6/30/27.
