 A Resolution confirming the award by the Board of Control of a renewal (second and final) of a professional service contract with Clarity Solutions Group, LLC, for automated mail processing services, for a one-year term, for the period of 1/1/26 through 12/31/26, at Cooperative Purchase Pricing, in an amount not to exceed \$100,000.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

 WHEREAS, the Executive's Department of Job and Family Services ("DJFS") wishes to enter an agreement with Clarity Solutions Group, LLC for automated mail processing services to provide an integrated print and mail workflow software solution and an inbound document automation platform. These services provide the following process improvements: virtual printing and mailing from remote locations, increased mailing accuracy, streamlined workflows, multiple options for client interactions, automated inbound document processing, integrated physical and digital communication channels and reduced manual labor on repetitive tasks; and

WHEREAS, this Council previously adopted Resolution No. 2024-014, which confirmed the award by the Board of Control of a professional service contract with Clarity Solutions Group, LLC, for automated mail processing services, for a one-year term, for the period of 1/1/24 through 12/31/24, with two options to renew for an additional one-year term, at Cooperative Purchase Pricing, in an amount not to exceed \$140,000.00; and

 WHEREAS, this Council subsequently adopted Resolution No. 2024-320, which confirmed the award by the Board of Control of a renewal (first of two) of a professional service contract with Clarity Solutions Group, LLC, for automated mail processing services, for a one-year term, for the period of 1/1/25 through 12/31/25, at Cooperative Purchase Pricing, in an amount not to exceed \$150,000.00; and

WHEREAS, the Board of Control, at its meeting held on November 5, 2025, awarded, subject to the approval of the Information Technology Board, a renewal (second and final) of a professional service contract with Clarity Solutions Group, LLC, for automated mail processing services, for a one-year term, for the period of 1/1/26 through 12/31/26, at Cooperative Purchase Pricing, in an amount not to exceed \$100,000.00, subject to confirmation by this Council; and

WHEREAS, the Information Technology Board, at its meeting held November 20, 2025, approved the aforementioned renewal (second and final) of a professional service contract with Clarity Solutions Group, LLC; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned renewal with Clarity Solutions Group, LLC, for the above-referenced services is necessary and in the best interest of the County of Summit;
