A Resolution to extend the final design report to April 1, 2026 for Springfield Township's Springfield Lake Outlet ditch petition pursuant to Section 6131.12 of the Ohio Revised Code, and declaring an emergency.

WHEREAS, on January 14, 2025, a single county petition for a drainage improvement was filed by Springfield Township with the Summit County Clerk of Council requesting the County repair the county ditch, which has caused flooding due to major storms in recent years and install measures to mitigate the erosive and flooding effect of future storms; and

WHEREAS, this Council previously adopted Resolution No. 2025-056 which authorized a viewing of the proposed improvement and set a public hearing pursuant to Section 6131.07 of the Ohio Revised Code; and

WHEREAS, a public viewing was held on April 17, 2025 and public hearing was held in Council Chambers on June 2, 2025; and

WHEREAS, after holding the public hearing on June 2, 2025, this Council adopted Resolution No, 2025-180 to authorize the Executive and the Engineer to solicit proposals for the preparation of plans, surveys, and project design, and set a date for the filing of such reports, plans, and schedules with this Council of December 31, 2025; and

WHEREAS, the Engineer has selected an engineering consultant to prepare reports, plans, and schedules, but said reports, plans, and schedules will not be completed until February 2026; and

WHEREAS, this Council wishes to extend the time for the filing of the reports, plans, and schedules as provided in Section 6131.12(C)(3) of the Ohio Revised Code.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Pursuant to Section 6131.12(C)(3) of the Ohio Revised Code, this Council hereby extends the due date for the filing of reports, plans, and schedules to be prepared by the Engineer for the Springfield Lake Outlet ditch petition to April 1, 2026 from December 31, 2025 as previously directed in Resolution No, 2025-180.
