7 **A Resolution to extend the final design report to April 1, 2026 for Copley**
8 **Township's Copley Ditch petition pursuant to Section 6131.12 of the Ohio Revised**
9 **Code, and declaring an emergency.**

11 WHEREAS, on May 12, 2025, a single county petition for a drainage
12 improvement was filed by Copley Township with the Summit County Clerk of Council
13 requesting the County repair the county ditch, which has caused flooding due to major
14 storms in recent years and install measures to mitigate the erosive and flooding effect of
15 future storms; and

16
17 WHEREAS, this Council previously adopted Resolution No. 2025-142 which
18 authorized a viewing of the proposed improvement and set a public hearing pursuant to
19 Section 6131.07 of the Ohio Revised Code; and

20
21 WHEREAS, a public viewing was held on July 21, 2025 and public hearing was
22 held in Council Chambers on September 8, 2025; and

23
24 WHEREAS, after holding the public hearing on September 8, 2025, this Council
25 adopted Resolution No, 2025-244 to authorize the Executive and the Engineer to solicit
26 proposals for the preparation of plans, surveys, and project design, and set a date for the
27 filing of such reports, plans, and schedules with this Council of December 31, 2025;

30 WHEREAS, the Engineer has selected an engineering consultant to prepare
31 reports, plans, and schedules, but said reports, plans, and schedules will not be
32 completed until February 2026; and

34 WHEREAS, this Council wishes to extend the time for the filing of the reports,
35 plans, and schedules as provided in Section 6131.12(C)(3) of the Ohio Revised Code.

37 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of
38 Summit, State of Ohio, that:
