7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Perram Electric, Inc. for the Canton Road and Sanitarium Road Intersection Improvement**
9 **Project, located in Springfield Township, in Council District 8, in an amount not to exceed**
10 **\$356,680.00, for the Engineer, and declaring an emergency.**

11
12 WHEREAS, the Canton Road and Sanitarium Road Intersection Improvement Project
13 (the "Project") will upgrade the existing traffic signal and a sidewalk from the Springfield High
14 School north driveway entrance to Sanitarium Road; and

15
16 WHEREAS, the Project work will also include additional curbing with ADA ramps,
17 crosswalks, and pedestrian push buttons to activate the pedestrian signals; and

18
19 WHEREAS, this Council previously adopted Resolution No. 2025-144, which authorized
20 the Executive to advertise for bids for the Canton Road and Sanitarium Road Intersection
21 Project, located in Springfield Township, in Council District 8, for an estimated total cost not to
22 exceed \$396,178.48; and

24 WHEREAS, the Engineer sent out six bid packages and following the receipt and review
25 of four bids, the Executive proposes entering into a construction contract with Perram Electric,
26 Inc. for the Project, in an amount not to exceed \$356,680.00; and

28 WHEREAS, the Board of Control, at its meeting held on November 19, 2025, awarded a
29 construction contract with Perram Electric, Inc. for the Project, located in Springfield Township,
30 in Council District 8, in an amount not to exceed \$356,680.00, subject to confirmation by this
31 Council; and

33 WHEREAS, this Council finds and determines after reviewing all pertinent information,
34 that the aforementioned construction contract with Perram Electric, Inc. is necessary and in the
35 best interest of the County of Summit;

37 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

42 The award by the Board of Control of a construction contract with a construction contract
43 with Perram Electric, Inc. for the Canton Road and Sanitarium Road Intersection Improvement
44 Project (the "Project"), located in Springfield Township, in Council District 8, in an amount not
45 to exceed \$356,680.00, is hereby confirmed and the Executive is hereby authorized to execute
46 said construction contract and any other necessary related documents.
