7 **A Resolution authorizing the Executive to advertise for bids for the sewer lining and**
8 **manhole rehabilitation construction for Project Q-185 Elimination of Hudson Sanitary**
9 **Sewer Overflow Area J, located in the City of Hudson, Council District 3, for an estimated**
10 **total cost not to exceed \$200,000.00, for the Executive's Department of Sanitary Sewer**
11 **Services, and declaring an emergency.**

13 WHEREAS, the Executive wishes to proceed with the sewer lining and manhole
14 rehabilitation construction for Project Q-185 Elimination of Hudson Sanitary Sewer Overflow
15 Area J ("Project Q-185"), located in the City of Hudson, in Council District 3; and

17 WHEREAS, this Council previously adopted Resolution No. 2017-359, Resolution No.
18 2020-315 and Resolution No. 2025-265 that authorized the County to execute and appropriate
19 funds for a professional services contract with CTI Engineers, Inc. for engineering design
20 services for Project Q-185; and

22 WHEREAS, this Council previously adopted Resolution No. 2022-027 that authorized
23 the County to execute and appropriate funds for a professional services contract with
24 Environmental Design Group, LLC for engineering design services for Project Q-185; and

25
26 WHEREAS, the Executive wishes to advertise for bids for construction of Project Q-185,
27 located in the City of Hudson, in Council District 3, for an estimated total cost not to exceed
28 \$200,000.00; and

30 WHEREAS, Section 177.05 of the Codified Ordinance of the County of Summit requires
31 this Council's authorization for the Executive to advertise for bids for construction contracts in
32 excess of \$75,000.00; and

34 WHEREAS, a copy of the plans and specifications for Project Q-185 are on file with the
35 Clerk of Council; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that it is necessary and in the best interest of the County to authorize the Executive to advertise
39 for bids for construction of Project Q-185 for an estimated total cost not to exceed \$200,000.00;

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that:

46 The Executive is hereby authorized to advertise for bids for the sewer lining and manhole
47 rehabilitation construction for Project Q-185 Elimination of Hudson Sanitary Sewer Overflow
48 Area J ("Project Q-185"), located in the City of Hudson, in Council District 3, for an estimated
49 total cost not to exceed \$200,000.00.
