WHEREAS, this Council previously adopted Resolution No. 2025-067, which confirmed the award of the Board of Control of a professional service contract with Roetzel Consulting Solutions, as a Best Practical Source, to provide economic development strategy, project management and consulting services to the County, for the period 1/1/26 through 12/31/26, with two options to renew for additional one-year terms, in an amount not to exceed \$96,000.00; and

WHEREAS, the Executive's Department of Community and Economic Development seeks to renew the professional service agreement in order to capitalize on recent successes in job creation and economic development in Summit County, to continue and further the County's role as one of the core Economic Development Organizations outlined in the Elevate Greater Akron strategic plan, and to continue to implement and oversee business retention and expansion efforts, business intelligence, project management and workforce development initiatives; and

WHEREAS, in order to continue and further the County's leadership role in creating and implementing a transformative, high functioning, and collaborative economic development system for the region, it is necessary to continue the relationship with Roetzel Consulting Solutions as they are a Best Practical Source pursuant to Sections 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit due to their expertise in the field and strong knowledge of the County's economic development strategy and initiatives; and

WHEREAS, the Board of Control, at its meeting held November 26, 2025 awarded the renewal (first of two) of a professional service contract with Roetzel Consulting Solutions, as a Best Practical Source, to provide economic development strategy, project management and consulting services to the County, for a one-year term, from 1/1/26 through 12/31/26, in an amount not to exceed \$96,000.00, subject to confirmation by this Council; and
