**An Amended Resolution confirming the award by the Board of Control of a renewal (third of four) of a professional service contract with Oriana House, Inc. for community corrections services for a one-year term, from 1/1/26 through 12/31/26, in an amount not to exceed ~~\$7,133,070.65~~ \$6,568,446.17, for the Executive's Department of Public Safety, and declaring an emergency.**

WHEREAS, this Council previously adopted Resolution No. 2023-021, which confirmed the award by the Board of Control of professional service contract with Oriana House, Inc., for day reporting, driver intervention, home incarceration, multiple offender, and residential community correction programming, for a one year term, from 1/1/23 through 12/31/23, with four options to renew for an additional one-year term, in an amount not to exceed \$8,980,912.97, for the Executive's Department of Public Safety; and

WHEREAS, this Council subsequently adopted Resolution No. 2024-013, which confirmed the award by the Board of Control of a renewal (first of four) of a professional service contract with Oriana House, Inc., for day reporting, driver intervention, home incarceration, multiple offender, and residential community correction programming, for a one year term, from 1/1/24 through 12/31/24, in an amount not to exceed \$9,250,340.35, for the Executive's Department of Public Safety; and

WHEREAS, this Council subsequently adopted Resolution No. 2025-028, which confirmed the award by the Board of Control of a renewal (second of four) of a professional service contract with Oriana House, Inc., for day reporting, driver intervention, home incarceration, multiple offender, and residential community correction programming, for a one year term, from 1/1/25 through 12/31/25, in an amount not to exceed \$9,490,655.40, for the Executive's Department of Public Safety; and

WHEREAS, the Executive and Oriana House Inc. agreed to remove the Community Alternative Sentencing Center ("CASC") from the residential programming of the section of this renewal for community corrections services, and establish a separate contract for the CASC; and

WHEREAS, the Board of Control, at its meeting held November 19, 2025, awarded a renewal (third of four) of a professional service contract with Oriana House, Inc. for community corrections services for a one-year term, from 1/1/26 through 12/31/26, in an amount not to exceed ~~\$7,133,070.65~~ \$6,568,446.17, subject to confirmation by this Council; and

WHEREAS, this Council has determined by reviewing all pertinent information that the aforementioned renewal of a professional service contract with Oriana House, Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a renewal (third of four) of a professional service contract with Oriana House, Inc. for community corrections services for a one-year term, from 1/1/26 through 12/31/26, in an amount not to exceed ~~\$7,133,070.65~~ \$6,568,446.17, is hereby confirmed and the Executive is hereby authorized to execute said renewal of a professional service contract and any necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further purpose of immediately providing continued community corrections services effective 1/1/26.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.


SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
