7 **A Resolution confirming the award by the Board of Control of a professional service contract**
8 **with Oriana House, Inc., as a Best Practical Source, for operation of the Community**
9 **Alternative Sentencing Center, for a 1-year term, from 1/1/26 through 12/31/26, for a total**
10 **amount not to exceed \$2,642,304.41, for the Executive's Department of Public Safety, and**
11 **declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2018-360, which established
14 a Community Alternative Sentencing Center ("CASC"); and

15
16 WHEREAS, since establishing the CASC, the County has contracted with Oriana House,
17 Inc. for the operation of the CASC facility through their community corrections services contract;
18 and

19
20 WHEREAS, this Council previously adopted Resolution No. 2023-021, which confirmed
21 the award by the Board of Control of professional service contract with Oriana House, Inc., for
22 day reporting, driver intervention, home incarceration, multiple offender, and residential
23 community correction programming, for a one year term, from 1/1/23 through 12/31/23, with four
24 options to renew for an additional one-year term, in an amount not to exceed \$8,980,912.97, for
25 the Executive's Department of Public Safety; and

27 WHEREAS, the County and Oriana House, Inc. agree to remove the CASC operations
28 from the community corrections contract for 2026, and wish to establish a separate contract with
29 Oriana House, Inc. for the operation of the CASC facility for the term of 1/1/26 through 12/31/26,
30 for an amount not to exceed \$2,642,304.41; and

32 WHEREAS, Oriana House, Inc. is a Best Practical Source pursuant to Sections
33 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit for the
34 continued operation of the CASC because they currently operate the facility and have operated
35 CASC since its inception; and

37 WHEREAS, the Board of Control, at its meeting held November 19, 2025, awarded a
38 professional service contract with Oriana House, Inc., as a Best Practical Source, for community
39 corrections services for a one-year term, from 1/1/26 through 12/31/26, in an amount not to exceed
40 \$2,642,304.41, subject to confirmation by this Council; and

42 WHEREAS, this Council has determined by reviewing all pertinent information that the
43 aforementioned professional service contract with Oriana House, Inc. is necessary and in the best
44 interest of the County of Summit;

46 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

4 SECTION 1

5
6 The award by the Board of Control of a professional service contract with Oriana House,
7 Inc., as a Best Practical Source, for community corrections services for a one-year term, from
8 1/1/26 through 12/31/26, in an amount not to exceed \$2,642,304.41, is hereby confirmed and the
9 Executive is hereby authorized to execute said professional service contract and any necessary
10 related documents.

12 SECTION 2

14 This Resolution is hereby declared an emergency in the interest of the health, safety and
15 welfare of the residents of the County of Summit, and for the further purpose of immediately
16 providing continued community corrections services effective 1/1/26.

18 SECTION 3

20 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
21 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and
22 be in force at the earliest time provided by law.

26 It is found and determined that all formal actions of this Council concerning and relating
27 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
28 deliberations of this Council and of any of its committees that resulted in such formal action, were
29 in meetings open to the public, in compliance with all legal requirements, including Section 121.22
30 of the Ohio Revised Code.
