7 **A Resolution authorizing the Executive to execute a renewal (first of four), of an**
8 **Intergovernmental Agreement with the City of Akron, for data hosting equipment and**
9 **services for the computer-aided dispatch system, for a one-year term, for the period of 1/1/26**
10 **through 12/31/26, in an amount not to exceed \$160,680.00, for the Executive's Department**
11 **of Public Safety and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2025-029, authorizing the
14 Executive to enter into an Intergovernmental Agreement with the City of Akron, to provide a data
15 hosting and backup solution to support the computer-aided dispatch (CAD) system, for the term
16 of 1/1/25 through 12/31/25, in an amount not to exceed \$156,000.00, with four options to renew
17 for an additional one-year term; and

19 WHEREAS, the Office of Information Technology Board, at its meeting to be held on
20 November 20, 2025, approved the aforementioned renewal of an Intergovernmental Agreement;

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that aforementioned renewal of an Intergovernmental Agreement with the City of Akron is
25 necessary and in the best interest of the County of Summit;

27 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The Executive is hereby authorized to execute a renewal (first of four) of an
33 Intergovernmental Agreement and any other necessary related documents with the City of Akron,
34 approved by the Office of Information Technology Board on 11/20/25, for data hosting equipment
35 and services for the computer-aided dispatch system, for a one-year term, for the period of 1/1/25
36 through 12/31/25, in an amount not to exceed \$160,680.00.

40 This Resolution is hereby declared an emergency in the interest of health, safety, and
41 welfare of the residents of the County of Summit, and for the further reason to be able to provide
42 continuity of public safety services to the residents of Summit County.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
47 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and
48 be in force at the earliest time provided by law.
