The Executive is hereby authorized to execute a professional service contract and any other necessary related documents, subject to the approval of the Board of Control, between the Legal Defender's Office of Summit County, Ohio, Inc. and the Summit County Public Defender Commission for legal defender services for indigents on behalf of the Commission, for a one-year term, for the period of 1/1/26 through 12/31/26, in an amount not to exceed \$7,283,062.00.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately provide necessary legal defender services for indigent persons in 2026.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
