14 amount of \$1,817,681.78 in order to meet obligations for the balance of 2025 calendar year as set  
15 forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated; and

17 WHEREAS, this Council has determined by reviewing all pertinent information that the  
18 appropriations contained in Exhibit A are immediately needed for operations of the County and  
19 are necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The Fiscal Officer is hereby authorized and directed to effect the appropriations set forth  
27 in Exhibit A, attached to this Resolution and incorporated herein as if fully restated and  
28 establishing fund(s) 2210 and 2241.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and  
34 welfare of the residents of the County of Summit and for the further reason that the appropriations  
35 contained in Exhibit A are immediately needed for operations of the County.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take effect  
40 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and  
41 be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating  
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
47 deliberations of this Council and of any of its committees that resulted in such formal action,  
48 were in meetings open to the public, in compliance with all legal requirements, including section  
49 121.22 of the Ohio Revised Code.
