7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **ZixCorp Systems, Inc., at GSA Co-op Pricing, for Office365 service with**
9 **Zix/AppRiver/OpenText as a Cloud Solution Provider, for a one-year term, from 4/12/26**
10 **through 4/11/27, in an amount not to exceed \$286,250.40, for the Office of Information**
11 **Technology, and declaring an emergency.**

13 WHEREAS, the migration of Office365 service over to Zix/AppRiver/OpenText as a
14 Cloud Solution Provider provided additional support and service management operations for the
15 County; and

16

17 WHEREAS, the Office of Information Technology recommends continued use of
18 Office365 service with Zix/AppRiver/OpenText as a Cloud Solution Provider for County
19 applications; and

21 WHEREAS, ZixCorp Systems, Inc. (“Zix”) is exempt from competitive bidding under
22 Section 177.07(a)(11) of the Codified Ordinances of the County of Summit as an approved Other
23 Public Cooperative Purchasing Association Pricing vendor; and

25 WHEREAS, the Board of Control, at its meeting held February 11, 2026, awarded a
26 purchase contract, subject to the approval of the Information Technology Board, with Zix, at
27 GSA Co-op Pricing, for Office365 service with Zix/AppRiver/OpenText as a Cloud Solution
28 Provider that will provide additional support and service management operations, for a one-year
29 term, from 4/12/26 through 4/11/27, in an amount not to exceed \$286,250.40, subject to
30 confirmation by this Council; and

32 WHEREAS, the Information Technology Board, at its meeting held on February 26,
33 2026, approved the aforementioned contract with Zix Corp Systems, Inc.; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 the aforementioned purchase contract with Zix Corp Systems, Inc. is necessary and in the best
37 interest of the County of Summit;

39 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
