7 **A Resolution appropriating funds in order to meet projected expenditures for the balance of**  
8 **2026 as set forth in Exhibit A, for the Executive’s Department of Finance and Budget, and**  
9 **declaring an emergency.**

11 WHEREAS, certain operations of the County of Summit require appropriations in the  
12 amount of \$48,066,982.60 and lowering appropriations in the amount of \$1,808,400.00 in order to  
13 meet obligations for the balance of 2026 calendar year as set forth in Exhibit A, attached to this  
14 Resolution and incorporated herein as if fully restated; and

16 WHEREAS, this Council has determined by reviewing all pertinent information that the  
17 appropriations contained in Exhibit A are immediately needed for operations of the County and  
18 are necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
21 of Ohio, that:

25 The Fiscal Officer is hereby authorized and directed to effect the appropriations set forth  
26 in Exhibit A, attached to this Resolution and incorporated herein as if fully restated and  
27 establishing fund(s) 2250, 2390, 2605, 2610, 2825, 2851, 2860, 2871, 4001, 4009, 4011, 4012,  
28 4015, 4101, 5101, 6009, and 6010.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and  
33 welfare of the residents of the County of Summit and for the further reason that the appropriations  
34 contained in Exhibit A are immediately needed for operations of the County.

36 SECTION 3

38 Provided this Resolution receives the affirmative vote of eight members, it shall take effect  
39 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and  
40 be in force at the earliest time provided by law.

44 It is found and determined that all formal actions of this Council concerning and relating  
45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
46 deliberations of this Council and of any of its committees that resulted in such formal action,  
47 were in meetings open to the public, in compliance with all legal requirements, including section  
48 121.22 of the Ohio Revised Code.
