Lease of Second Floor Office Space at 175 South Main Street, Akron, Ohio, 44308

THIS FIRST AMENDMENT AND RENEWAL OF THE LEASE AGREEMENT is made between the County of Summit, Ohio (Landlord) and Service Corps of Retired Executives Association, Chapter 81 aka Akron Score, an Ohio nonprofit corporation (Tenant).

WHEREAS, on August 5, 2022 a Lease was executed between Landlord and Tenant with the term of said lease being August 1, 2021 through July 31, 2026, for Second Floor office space with one 5-year renewal.

WHEREAS, due to ongoing renovations at 175 South Main Street, the Parties agree to amend the Premises section of said lease.

WHEREAS, as authorized by County Resolution No. 26-____, a Lease Amendment and Renewal Agreement was authorized by County Council with any amendments not materially adverse to the county.

THEREFORE, in consideration of the mutual covenants and conditions contained herein and intending to be legally bound, the Landlord and Tenant agree as follows:

- 1) To the Premises section the following language is added at the end “Landlord reserves the right to relocate Tenant as needed for repairs and/or renovations to the Premises. Landlord will attempt to find county-owned property that allows Tenant to continue its core activities. Parties will cooperate when relocation is needed for repairs and/or renovations.”
- 2) The term of said Lease Agreement is hereby renewed for five years, covering the period of August 1, 2026, through July 31, 2031.

All other terms and conditions of the Lease, not modified by the terms of this Amendment and Renewal shall remain in full force.
