7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Melway Paving Company, Inc., for the 2026 Summit County 405 Resurfacing Program, in**
9 **an amount not to exceed \$1,354,193.80, for the Engineer, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2025-333, which authorized
12 the Executive to advertise, as needed, for bridge engineering and construction projects, and
13 pavement maintenance projects, for the Engineer’s 2026 Capital Improvements Program, and
14 federal and state funded projects, for an estimated total cost not to exceed \$7,925,000.00; and

15
16 WHEREAS, said projects were approved as part of the Capital Improvements Program
17 for 2026-2031 by Resolution No. 2026-009; and

18
19 WHEREAS, the work to be performed will consist of resurfacing various County, Bath
20 Township, Richfield Township, Springfield Township, and Twinsburg Township roads,
21 including milling, pulva-mixing, making pavement repairs as directed by the Engineer and
22 adding of surface course of 405 Bituminous Cold Mix and applying new pavement markings;
23 and

25 WHEREAS, the contract total will be broken down by political subdivision as follows
26 with each subdivision responsible for directly paying the contractor:

28 County share: \$346,659.25 (Includes Alternate No. 1)
29 Bath Twp: \$476,398.55 (Includes Alternate No. 2)
30 Richfield Township: \$58,078.50
31 Springfield Township: \$417,147.50 (Includes Alternative No. 3)
32 Twinsburg Township: \$55,910.00; and

34 WHEREAS, the Engineer sent out three bid packets and following the receipt and review
35 of the one bid received, the Executive proposes entering into a construction contract with
36 Melway Paving Company, Inc., as the lowest responsive and responsibly bidder, for the 2026
37 Summit County 405 Resurfacing Program, in an amount not to exceed \$1,354,193.80; and

39 WHEREAS, the Board of Control, at its meeting held March 18, 2026, awarded a
40 construction contract with Melway Paving Company, Inc., as the lowest responsive and
41 responsible bidder, for the for the 2026 Summit County 405 Resurfacing Program, in an amount
42 not to exceed \$1,354,193.80, subject to confirmation by this Council; and

44 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
45 that aforementioned construction contract with Melway Paving Company, Inc. is necessary and
46 in the best interest of the County of Summit;

48 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

6 The award by the Board of Control of a construction contract with Melway Paving
7 Company, Inc., for the 2026 Summit County 405 Resurfacing Program, in an amount not to
8 exceed \$1,354,193.80, is hereby confirmed and the Executive is hereby authorized to execute
9 said construction contract and any other necessary related documents.

13 This Resolution is hereby declared an emergency in the interest of the health, safety and
14 welfare of the residents of the County of Summit, and for the further purpose to immediately
15 provide a necessary construction contract for the 2026 Summit County 405 Resurfacing
16 Program.

20 Provided this Resolution receives the affirmative vote of eight members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.

27 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
