7 **A Resolution authorizing the Executive to execute a collective bargaining agreement**
8 **between Ohio Council 8 and Local 1229 of the American Federation of State, County and**
9 **Municipal Employees, AFL-CIO (Medical Examiner), and the County of Summit for the**
10 **period of 4/1/26 through 3/31/29, for the Executive, and declaring an emergency.**

11
12 WHEREAS, a collective bargaining agreement has been reached between Ohio Council 8
13 and Local 1229 of the American Federation of State, County and Municipal Employees, AFL-
14 CIO (Medical Examiner), and the Executive, for the period of 4/1/26 through 3/31/29, with an
15 increase in pay of four percent (4.0%) in the first year of the agreement (4/1/26), three and one-
16 half percent (3.5%) in the second year of the agreement (4/1/27), and three percent (3.0%) in the
17 third year of the agreement (4/1/28); and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that it is necessary and in the best interest of the County to authorize the Executive to execute the
21 aforementioned collective bargaining agreement;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

26 SECTION 1

27
28 The Executive is hereby authorized to execute a collective bargaining agreement between
29 Ohio Council 8 and Local 1229 of the American Federation of State, County and Municipal
30 Employees, AFL-CIO (Medical Examiner), and the County of Summit, for the period of 4/1/26
31 through 3/31/29, with an increase in pay of four percent (4.0%) in the first year of the agreement
32 (4/1/26), three and one-half percent (3.5%) in the second year of the agreement (4/1/27), and
33 three percent (3.0%) in the third year of the agreement (4/1/28).

37 This Resolution is hereby declared an emergency in the interest of the health, safety, and
38 welfare of the residents of the County of Summit and for the for the further purpose of providing
39 a timely collective bargaining agreement between Local 1229 of the American Federation of
40 State, County and Municipal Employees, AFL-CIO (Medical Examiner), and the Executive.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
