7 **A Resolution confirming the award by the Board of Control of a professional design service**
8 **agreement with Orchard, Hiltz & McCliment dba OHM Advisors, for the design of the**
9 **Killian-Pickle Roundabout Project, located in Springfield Township, in Council District 8,**
10 **in an amount not to exceed \$192,811.00, for the Engineer, and declaring an emergency.**

11

12 WHEREAS, an Intersection Safety Study funded by the Ohio Department of
13 Transportation was prepared by TMS Engineers and completed on June 6, 2023. The study
14 recommends a roundabout to improve safety at the Killian-Pickle Intersection, located in
15 Springfield Township, in Council District 8; and

16

17 WHEREAS, the County has received \$240,000.00 in funding for right-of-way and
18 \$1,750,000.00 in funding for construction from Akron Metropolitan Area Transportation
19 Study (AMATS). Construction and right-of-way funding is 80% federal with a 20% local match.
20 Construction of this project is scheduled for 2030; and

22 WHEREAS, the Engineer requested qualifications from five firms, of which four
23 responded, for the design of the Killian-Pickle Roundabout Project, located in Springfield
24 Township, in Council District 8; and

26 WHEREAS, after considering the four proposals, the Executive and Engineer selected
27 Orchard, Hiltz & McCliment dba OHM Advisors (“OHM Advisors”) as the highest scoring and
28 most qualified firm and the Engineer has negotiated the scope of services; and

30 WHEREAS, the Board of Control, at its meeting held April 8, 2026, awarded a
31 professional design service contract with OHM Advisors for the design of the Killian-Pickle
32 Roundabout Project, located in Springfield Township, in Council District 8, in an amount not to
33 exceed \$192,811.00, subject to confirmation by this Council; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that the aforementioned professional design service contract with OHM Advisors is necessary
37 and in the best interest of the County of Summit;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that:

44 The award by the Board of Control of a professional design services agreement with
45 Orchard, Hiltz & McCliment dba OHM Advisors for the design of the Killian-Pickle
46 Roundabout project, located in Springfield Township, in Council District 8, in an amount not to
47 exceed \$192,811.00, is hereby confirmed and the Executive is hereby authorized to execute said
48 professional design service contract and any other necessary related documents.
