MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on November 16, 2017, the County Executive submitted to the Council President and Clerk of Council seven letters nominating Mr. Brian Nelsen, Mr. Alan Brubaker, Mr. Paul Schweikert, Mr. David Hamilton, Mr. Robert Genet, Mayor Michael Rick for reappointment, and the appointment of Mayor Mike Zita to the Community Development Block Grant Committee.

Whereas, upon receipt of an appointment nominating letter, Section 121.06 of the Codified Ordinances of the County of Summit requires the Council President to present a Motion of Council to the County Council for its consideration and action;

- (6) The reappointment of Mayor Michael A. Rick to the Community Development Block Grant Committee with a term beginning January 1, 2018 and ending December 31, 2018, to serve without compensation, is hereby confirmed.

- (7) The appointment of Mayor Mike Zita to the Community Development Block Grant (CDBG) Committee with a term beginning January 1, 2018 and ending December 31, 2018, to serve without compensation, is hereby confirmed.


