MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on August 18, 2021 and August 23, 2021, the County Executive submitted to the Council President and Clerk of Council a total of four letters nominating the appointments of Christina Hodgkinson (with alternate Joan Davidson and replacing David Horner) and Lisa Kamlowky (replacing Lori Pesci), and confirming Greta Johnson (as alternate for Colleen Kelly) and David Horner (as alternate for Rashara Walker) to the Child Fatality Review Board; and

Whereas, upon receipt of an appointment nominating letter, Section 121.06 of the Codified Ordinances of the County of Summit requires the Clerk of Council to prepare a Motion of Council for consideration at the next Regular Council meeting;

NOW, THEREFORE, IT IS MOVED AND APPROVED, BY THE COUNCIL OF THE COUNTY OF SUMMIT, that:



- (4) The designation of David Horner (as alternate to Rashara Walker) to the Child Fatality Review Board, with a term commencing at the passage of this motion to 5/7/25, to serve without compensation, is hereby confirmed.
