SUMMARY:

MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on December 8, 2023, the County Executive submitted to the Council President and Chief of Staff one letter nominating Mayor Shammias Malik (replacing Mayor Dan Horrigan), Interim Chief Brian Harding (replacing Chief Stephen Mylett) and Chief Scott Cottle (replacing Eric Czetli) as alternate for Sheriff Kandy Fatheree, to the Criminal Justice Advisory Board; and


Whereas, upon receipt of an appointment nominating letter, Section 121.06 of the Codified Ordinances of the County of Summit requires the Clerk of Council to prepare a Motion of Council for consideration at the next Regular Council meeting;

NOW, THEREFORE, IT IS MOVED AND APPROVED, BY THE COUNCIL OF THE COUNTY OF SUMMIT, that:

- (3) The appointment of Chief Scott Cottle (replacing Eric Czetli) as alternate for Sheriff Kandy Fatheree to the Criminal Justice Advisory Board, with a term beginning at the passage of this motion to 6/14/25, to serve without compensation, is hereby confirmed.
