SUMMARY:

MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on January 18, 2024, the County Executive submitted to the Council President and Clerk of Council one letter nominating Jill Spillman (replacing Christina Hodgkinson) with alternate Hannah Horrigan, Jill Oldman (replacing Dawn Glenny) with alternate Joan Davidson (replacing Michelle Watkins), and Judge Jennifer Towell (replacing Judge Susan Baker Ross) with alternate Kerri Defibaugh to the Child Fatality Review Board; and

Whereas, upon receipt of an appointment nominating letter, Section 121.06 of the Codified Ordinances of the County of Summit requires the Clerk of Council to prepare a Motion of Council for consideration at the next Regular Council meeting;

- (3) The appointment of Judge Jennifer Towell (replacing Judge Susan Baker Ross) with alternate Kerri Defibaugh to the Child Fatality Review Board, with a term beginning at the passage of this motion to 5/7/25, to serve without compensation, is hereby confirmed.
