MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on November 21, 2024, the County Executive submitted to the Council President and Clerk of Council one letter nominating the reappointments of County Engineer Alan Brubaker, Diane Miller-Dawson, Mayor Mike Rick, Sagamore Hills Township Trustee Paul Schweikert, Mayor Mike Zita and Tazena Long to the Community Development Block Grant Committee; and


