MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on November 6, 2025, the County Executive submitted to the Council President and Clerk of Council one letter reappointing Executive Ilene Shapiro, Summit County Engineer Alan Brubaker, Diane Miller-Dawson, Curtis Baker and Mayor Russell Sharnsky to the Transportation Improvement District Board of Trustees; and

- (4) The reappointment of Curtis Baker to the Transportation Improvement District Board of Trustees with a term beginning 2/8/25 and ending 2/7/27, to serve without compensation, is hereby confirmed.
- (5) The reappointment of Mayor Russell Sharnsky to the Transportation Improvement District Board of Trustees with a term beginning 2/8/25 and ending 2/7/27, to serve without compensation, is hereby confirmed.
