

**SUMMARY:**

**A Motion of Council amending M-003-2025, stating the correct term of 1/27/25 to 1/26/26 for the appointment of Traci Buckner, the correct term of 1/27/25 to 2/26/27 for the appointment of Molly Hartong, and the correct term of 1/27/25 to 1/26/27 for the appointment of Howard Parr to the Summit County Regional Arts & Culture District.**

**MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT**

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

Whereas, on December 11, 2025, the County Executive submitted to the Council President and Clerk of Council one letter requesting that the term of 1/27/25 to 1/26/28 previously submitted and approved for the appointment of Traci Buckner be corrected to 1/27/25 to 1/26/26, the term of 1/27/25 to 1/26/28 previously submitted and approved for the appointment of Molly Hartong be corrected to 1/27/25 to 2/26/27, and the term of 1/27/25 to 1/26/28 previously submitted and approved for the appointment of Howard Parr be corrected to 1/27/25 to 1/26/27 to the Summit County Regional Arts & Culture District through Motion M-003-2025; and

Whereas, upon receipt of an appointment nominating letter, Section 121.06 of the Codified Ordinances of the County of Summit requires the Clerk of Council to prepare a Motion of Council for consideration at the next Regular Council meeting;

NOW, THEREFORE, IT IS MOVED AND APPROVED, BY THE COUNCIL OF THE COUNTY OF SUMMIT, that:

- (1) The appointment of Dr. Leslie Parker Barnes to the Summit County Regional Arts & Culture District, with a term of 1/27/25 to 1/26/28, to serve without compensation, is hereby confirmed.
- (2) The appointment of Traci Buckner to the Summit County Regional Arts & Culture District, with a term of 1/27/25 to 1/26/26, to serve without compensation, is hereby confirmed.
- (3) The appointment of Molly Hartong to the Summit County Regional Arts & Culture District, with a term of 1/27/25 to 2/26/27, to serve without compensation, is hereby confirmed.
- (4) The appointment of Phil Montgomery to the Summit County Regional Arts & Culture District, with a term of 1/27/25 to 1/26/28, to serve without compensation, is hereby confirmed.

- (5) The appointment of Howard Parr to the Summit County Regional Arts & Culture District, with a term of 1/27/25 to 1/26/27, to serve without compensation, is hereby confirmed.
