MOTION OF THE COUNCIL OF THE COUNTY OF SUMMIT

Whereas, Section 2.03(2) of the Charter of the County of Summit provides that the Executive appoints officers and members of boards, agencies, commissions and authorities required by general law to be appointed by boards of county commissioners subject to confirmation by County Council; and

- (5) The appointment of Don Taylor to The Summit Health and Safety Innovation Fund with a term of 2/9/26 to 2/8/27, to serve without compensation, is hereby confirmed.
- (6) The appointment of Lori Pesci to The Summit Health and Safety Innovation Fund with a term of 2/9/26 to 2/8/28, to serve without compensation, is hereby confirmed.
