Council Special Review Committee Issues Second Racism as a Public Health Crisis Report

The special review committee convened by Summit County Council in 2020 to examine how to best promote racial equity in the County presented findings to the full Council and community at the January 31 Council Committee Meeting. The work, led by Council member Veronica Sims (District 5) and Council President Elizabeth Walters (at-large) and with assistance from County Executive Ilene Shapiro and staff, has focused on how the County can improve internal policies, practices, and procedures to foster operations that are antiracist, diverse, equitable and inclusive (ADEI). The committee completed two phases of work and is set to begin the third and final phase in the coming months.

Special review committee members met monthly in 2021 to seek solutions and engage residents. Committee members include elected officeholders and community stakeholders. Later in 2021, the County hired UPD Consulting to facilitate committee meetings, collect, analyze and report on data, develop a work plan, review data collection and provide county officials with recommendations, ideas and assistance to improve policies and procedures related to diversity, equity and inclusion.

Both quantitative and qualitative methods were applied to assess many aspects of Summit County departments and agencies

Walters and Dickinson lead Council in 2022



Elizabeth Walters (At-Large) was re-elected to serve as President of Council for 2022 and Clair Dickinson (At-Large) was re-elected to serve as Vice President following the Summit County Council Organizational Meeting In January. Walters, elected to County Council in 2016 served as Council Vice President in 2019 and 2020. She currently serves as Chair of the Ohio Democratic Party.



Dickinson has recently served as Chair of the Public Safety Committee and Vice-Chair of the Finance Committee. He previously served on Council from 1989 through 1993 and from 2003 through 2007 and served as President three times. He also served a total of twelve years as a Judge on the Ohio Ninth District Court of Appeals and worked for several years with the Brouse McDowell law firm.

Council Honors GOJO for 75 Years

At its February 28th meeting, Summit County Council and County Executive Ilene Shapiro honored GOJO Industries with a commendation, marking the company's 75th Anniversary.

Councilman **John Schmidt (District 2)** presented the honor along with Executive Shapiro to GOJO President and CEO, Carey Jaros.

Founded in 1946 by Goldie and Jerry Lippman in Akron, Ohio, GOJO is a privately held manufacturer of hand hygiene and skin care products. One of Summit County's largest private employers, GOJO remains headquartered in Akron and operates worldwide, with offices in the United Kingdom, France, Australia, Japan, and Brazil. It has factories in Ohio and across North America, as well as in Latin America, South America, Europe, and Asia. Gojo's main manufacturing and distribution facilities are at its Lippman Campus in Cuyahoga Falls. The company is best known for Purell, a hand sanitizer. The company also offers an electronic hand hygiene monitoring system for medical, government, military, education, food and leisure institutions and industrial and office facilities.

"When people think of GOJO they think of Purell, but what's really amazing is that GOJO is a third generation family business born and developed right here in Summit County. GOJO has always been about innovative solutions to improve our everyday lives – from not only the development of Purell and other sanitizers but to the safe and efficient distribution of them that we see today in our homes, businesses, offices and medical facilities everywhere," said Schmidt.

"During this current COVID pandemic it is incredible that such a product is made and manufactured here locally and helps keep people safe and healthy while providing thousands of dedicated employees the opportunity to earn a good living and provide for their families. We truly appreciate GOJO and their positive impact on this community and beyond for 75 years," he concluded.

Racism Special Committee Report cont.

To determine findings and develop recommendations, UPD utilized data analysis, staff surveys, interviews and focus groups, and document review. UPD's report showed that Summit County is on its way to becoming an ADEI organization, but has work to do to foster stronger community, commitment, culture and climate in County operations. To begin Phase III, Council Co-Chairs Sims and Walters are now assembling a smaller working group to define a vision and set goals for the County to meet. This group will work together in the coming months to develop a longer-term strategy for ADEI work and outline performance management metrics.

"This work is about change, not blame. If we have learned anything since beginning this journey, it is that systems, not just individual people, are responsible for present inequities," said Council President Walters. "It is also clear that change will require bold leadership. I am certain my colleagues on County Council, County Executive Shapiro and all County officeholders, in addition to our other County agencies, are willing to engage in the hard work that lays ahead."

"Since engaging in this work, we have received overwhelmingly positive feedback from our internal and external partners. These partners are excited to know the County is committed to taking action, not just talking about the problem," said Councilmember Sims. "In the coming months, we will plot a roadmap forward, focusing on recommendations provided by the committee and UPD, and working to deliver a model for other communities and organizations to follow."
