## **Council Selects New Officers for 2024**

At their February 12, 2024 Council Meeting, Summit County Council selected **Rita Darrow** (**District 1**) to serve as Council President and **Erin Dickinson** (**At Large**) as Vice President for the remainder of 2024. Darrow succeeds Councilwoman **Veronica Sims** (**District 5**) who served from 2023 through February 2024. Sims resigned from County Council on February 7, to serve as State Representative for the 33<sup>rd</sup> District in the Ohio House of Representatives.

Elected to Summit County Council in 2020, Darrow has served as Vice President since 2023 and has chaired the Health and Human Services and Long Term Planning Committees and been vice chair of the Personnel Committee. Councilwoman Darrow has also served on the on the Public Safety Committee. Prior to County Council, she served on the Macedonia City Council and was a past president there. Darrow also serves as third vice president of the Federated Women of Summit County.

Dickinson has served on Council since 2022 and has chaired the Public Safety and Rules Committees and been vice chair of the Public Works Committee. She also serves on the Long Term Planning Committee. Councilwoman Dickinson has spent her career as a business litigation attorney and advocates for safter communities through her role on the Community Legal Aid Board.

#### **Brandon Ford Selected For District 5 Seat on Council**



Brandon Ford was selected by the Summit County Democratic Committee to fill the District 5 seat vacated by Veronica Sims who left Council in February to represent District 33 in the Ohio House of Representatives. Ford holds a Juris Doctorate and MBA from the University of Akron and his BS in Nursing from Case Western Reserve. "From my foundation as a PICU nurse, to the years I spent as an attorney, to starting my own venture to my role as the ignitor of innovation with Lubrizol, my passion and drive are behind everything I do. I'm looking forward to serving the constituents of

District 5 and working with my new colleagues on Summit County Council," he concluded. Councilman Ford will conclude Sims' term and run for re-election in November 2024.

# Council Honors Akron Police Officer For Saving a Child's Life From Overdose

At its March 4 Council Meeting, Summit County Council honored Akron Police Detective Larry Rhodaback for his heroism in saving the life of a young child. On the evening of January 11, 2024, Detective Rhodaback was working his secondary job at the Martin P. Lauer Apartments when he came across a father who was carrying his unconscious child. Detective Rhodaback performed CPR on the child for several minutes before she started breathing again. EMS arrived shortly after, taking over and continuing life-saving measures. The child was then transported to Akron Children's Hospital where it was discovered that fentanyl was in her system. The child was then taken into the custody of Summit County Children Services while investigators worked to find out how she digested the lethal drug. "We want to thank Detective Rhodaback for his quick action assisting this child and ultimately saving their life," said Councilman John Schmidt (District 2). We have seen the devastating impact fentanyl has had on our community and as this event illustrates, not even children are immune to its harm," he concluded.
