**A Resolution confirming an award by the Board of Control of a various contracts, attached hereto as Exhibit A and incorporated herein as if fully restated, for the second and final renewal of Workforce Investment Act Education and Employment Services for in- and out-of-school youth, for the period 7/1/09 to 6/30/10, in an amount not to exceed \$654,391.00, for the Executive's Department of Job and Family Services, and declaring an emergency.**

WHEREAS, the Board of Control, at its meeting held April 8, 2009, has awarded various contracts for the aforementioned services, subject to confirmation by County Council; and.

WHEREAS, County Council has determined by reviewing all pertinent information that the contracts are necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of various contracts, attached hereto as Exhibit A and incorporated herein as if fully restated, for the second and final renewal of Workforce Investment Act Education and Employment Services for in- and out-of-school youth, for the period 7/1/09 to 6/30/10, in an amount not to exceed \$654,391.00, is hereby confirmed, and the County Executive is authorized to execute such contracts.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit and for the further reason of immediately providing such contracts.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
