WHEREAS, the Prosecutor has received approval from the Akron Community Foundation of said appropriation adjustments in the amount of \$1,980.00 and to extend the grant period to 12/31/2009; and

WHEREAS, this Council has determined by reviewing all pertinent information that the aforementioned appropriation adjustments are necessary and in the best interest of the County of Summit;
