A Resolution authorizing the County Executive to execute any documents necessary to accept a Workforce Investment Act ("WIA") Stimulus Allocations award for the WIA Area 20, of \$4,914,541.00 from the Ohio Department of Job and Family Services ("ODJFS"), with no local cash match requirement, for the period February 17, 2009 through June 30, 2010, and appropriating these funds for WIA expenditures through December 31, 2009, for the Executive, and declaring an emergency.

WHEREAS, the American Recovery and Reinvestment Act of 2009 ("ARRA") provides WIA Area 20, being Summit and Medina Counties, with a WIA federal stimulus allocations for allowable expenditures made between February 17, 2009 and June 30, 2010; and

WHEREAS, Summit County is the fiscal agent for Local Area 20 departments of job and family services, which includes Summit and Medina Counties, and is required by such to distribute State Pass-Through WIA funds as prescribed, and receives administrative funding for these services; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute any document necessary to accept the award of the aforementioned grant from the Ohio Department of Job and Family Services, and to authorize the expenditure of \$4,914,541.00;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute any documents necessary to accept an award from the Ohio Department of Job and Family Services in the amount of \$4,914,541.00, with no local cash match requirement.


SECTION 6


