An amended Resolution appropriating \$44,000.00 in additional funds and adjusting \$7,000.00 in current appropriations in the Domestic Relations Court Special Projects Fund and \$2,750.00 in current appropriations in the General Fund for the period ending 12/31/2009, for the Domestic Relations Court, and declaring an emergency.

WHEREAS, additional revenue is projected to be received in the Domestic Relations Court Special Projects Fund for 2009 and the Domestic Relations Court wishes to appropriate the additional funds to ease the burden on the County's General Fund 2009 appropriations; and

WHEREAS, additional appropriations in the amount of \$44,000.00 in the Special Projects Fund and adjustments to appropriations in the amount of \$7,000.00 in the Special Projects Fund and \$2,750.00 in the General Fund, are needed to meet projected expenditures for the balance of 2009; and

WHEREAS, this Council has determined by reviewing all pertinent information that the appropriation of the aforementioned funds and the adjustments to appropriations are necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:


SECTION 6
